Terms And Conditions of Rental Reservations

All bookings are nominative and can not, under any circumstances, be assigned or subleased. The customer will enjoy places and furniture "in good father". He will have to read the rules of procedure.

1- CANCELLATION :

We strongly advise the tenant to provide a 'cancellation insurance' in a private capacity.

We offer Axelliance insurance. This product is available if you book online or on request. (Conditions and rates on our website).

Without insurance and for any cancellation, we ask a registered mail.

If the cancellation is received with three months notice, the deposit will be refunded

deduction of 30% of the amount of the stay plus the administration fees.

If it is received after, neither the deposit nor the expenses of file will be refunded.

Any delay not reported above 48h cancels the rental system and leads to the loss of the deposit and fees and the rented stay.

2- MODIFICATION OR POSTPONEMENT OF STAY :

For any postponement of stay, we ask for a registered letter. The management fees are offered for the first request to modify the stay. A maximum of two change requests are allowed.

Any request for modification is subject to the agreement of the campsite. Any costs generated by the request for modification of dates or classification of accommodation will be borne by the customer. The price recalculated following this request to modify a stay will always be calculated on the prices applied on the date of the customer's initial reservation and not on the date of the request to modify the stay.

A postponement of stay to the following year is impossible except in exceptional cases given by written agreement of the management of the Merendella campsite. The postponement conditions are the same as those for the cancellation of a stay. In no case may a carryover to the following year be modified or postponed again. Any cancellation that would be requested following this type of postponement systematically cancels the rental and results in the loss of the deposit and booking fees as well as the rented stay.

3- PAYMENT :

The booking of a rental is effective only after written confirmation from us upon receipt of the deposit is equivalent to 30% of the amount of the stay.

In order for this to be definitively validated and maintained, the balance of the stay must be paid in full 1 month before your arrival.

Upon receipt of the balance, you will receive our written confirmation for final validation of your stay.

Without this written confirmation from us, your stay is not validated.

No reduction will be granted in the case of delayed arrival or early departure.

Holiday checks are accepted for payment of the balance and in no case for the down payment.

They must be in the name of the reservation.

The Management declines all responsibility in the event that adverse weather conditions result in the removal of certain services or certain events. In no case, these bad climatic conditions will give rise to any reduction or refund, integral or partial.

4- ARRIVAL AND DEPARTURE :

Your arrival :

Your rental will be available from 16H until 21H the day of your arrival.

On your arrival, the inventory and inventory will be made by you and returned to the maximum the next day at the reception.

Your departure :

You will have to make an appointment for the inventory of fixtures 48H before your departure.

The day of appointment, the rental will be emptied and must be returned in perfect condition.

5- DEPOSIT :

To guarantee the return in good condition of the premises and furniture, the tenant must deposit a deposit of € 250 on arrival and € 700 for rentals with SPA. It will be returned the day of his departure after inventory and inventory of mobile home.

No claim will be considered after this time.

At your departure, the inventory will be made by us and in your presence only the morning of your departure between 8h30 and 12h.

It will be necessary to make an appointment for the inventory of departure at least 48 hours in advance.

If we can not make an appointment together, we will send your deposit by post (deposit by check) or by mail (deposit by credit card).

6- MAINTENANCE :

We ask you to be conscientious and think of those who will occupy the place after you. If the departure cleaning has not been done by the tenant, he will be charged a flat fee of € 50 to € 120 depending on the model of the rental. (A paid service of household is possible on reservation on the same bases tariffs)

Each mobile home is equipped with pillows and mattress pads that must be absolutely protected by your bedding if you have not reserved a sheet rental.

The loss of the keys results in the change of the door barrel which will be invoiced to the tenant.

Any problem or failure of a system should in no case be repaired or "arranged" by you but declared at the reception so we have an authorized technician.

Any item broken, damaged or missing should not be replaced by the tenant, but by us, and it will be charged.

7- RULES OF PROCEDURE :

For the comfort and safety of all camping Merendella has an internal regulation. As a customer you are obliged to read and apply it.
